



## CONSENT TO RECEIVE EMERGENCY BROADBAND BENEFIT THROUGH CALTEL INTERNET

As either a current or new customer of CalTel Connections d/b/a CalTel Internet ("CalTel Internet"), by signing below, you have consented to receive broadband Internet access service from CalTel Internet at a discounted rate funded by the federally-sponsored Emergency Broadband Benefit ("EBB") Program.

In connection with enrolling in the EBB Program and receiving a reduced rate through CalTel Internet, CalTel Internet notifies you of the following:

- The EBB Program is a federal government program that reduces your broadband Internet access service bill. To establish your eligibility for the EBB Program, CalTel Internet must provide the following information about you to a national data base administrator:
  - your full name;
  - your full residential address;
  - your date of birth;
  - the telephone number associated with your broadband Internet access service;
  - the date on which the EBB Program discount was initiated.
  - the date on which the EBB Program discount was terminated (when that occurs);
  - the amount of EBB Program support being sought for you; and
  - the information that establishes your qualification for the EBB Program.
- The benefit from the EBB Program may be applied to only one broadband Internet access service per household.
- The EBB Program is TEMPORARY in nature, and, although it is not currently known how long the EBB Program will last, the federal government has specified that it will issue a notice 60 days prior to the end of the EBB Program.
- Upon conclusion of the EBB Program, you will be subject to CalTel Internet's undiscounted rates and general terms and conditions if you continue to receive broadband Internet access service from CalTel Internet. Once the EBB Program ends, the discount of \$50 will be removed and your rates will return to the regular rate for your speed.
- You may obtain broadband Internet access service supported by the EBB Program from any participating provider of your choosing which serves your household.
- You may transfer your EBB Program benefit to another participating provider which serves your household at any time.

### Acknowledgement, affirmation and consent by customer:

By signing below, I acknowledge receipt of the information specified above regarding the EBB Program. I also affirm that I understand that the EBB Program is a temporary federal government subsidy that reduces my broadband Internet access service bill and, at the conclusion of the EBB Program, I will be subject to CalTel Internet's undiscounted general rates, terms, and conditions if I continue to subscribe to CalTel Internet's broadband Internet access service. I hereby consent to CalTel Internet providing the information described above to the national database administrator and applying the Emergency Broadband Benefit to the

broadband Internet access service that I receive from CalTel Internet. Other than the rate charged for broadband Internet access services, the terms and conditions specified in the Internet Service Agreement with CalTel Internet shall continue to apply during the period in which my bill is reduced by the EBB Program.
